Register Early!!! You are strongly urged to register your child early. Enrollment is limited to available openings only.

AVOID BEING CLOSED OUT.

Proof of Residency: All children who attend the program are checked against District 13 class lists. Private school children who receive bus transportation are checked against the bus lists.

All other children: Proof of residency for the family (copy of utility bill, etc...) plus proof of school enrollment for the child (i.e., a copy of a recent report card showing the school's name) is required for all other children. Families who register in the District after May 1, are asked to include proof of school registration.

YOUR REGISTRATION FORM WILL BE RETURNED IF BOTH PROOFS ARE NOT INCLUDED. PROOF WILL NOT BE RETURNED. DO NOT SEND ORIGINALS. SEND COPIES ONLY.

Since such a large number of children registers for this program, registration will not be confirmed by telephone or mail. Your canceled check is your proof of payment.

Grouping: Children are grouped according to their grade in school. Kindergartners have the option of registering in the school they will attend in September or their home school. Past experience has been that many children with an older sibling in the program go to the home school and children without a sibling in the program go to the school they will attend in September. Children participating in the Prime Time Hockey program at the Wheeler Avenue School have the option of registering and attending the Summer Recreation at Wheeler or at their home school.

Children that do not behave according to the Valley Stream UFSD Code of Conduct will be dismissed from the Summer Recreation Program.
